Introduction and Background

On April 23, 2007 in a follow-up meeting of the Organizing Committee for (First) International Conference on Water and Flood Management (ICWFM-2007) it was decided that ICWFM should be organized as a biennial event. Later, in 2008 this decision was approved by the Board of Governors of Institute of Water and Flood Management (IWFM), BUET. Accordingly, ICWFM-2009 was held during 15-17 March, 2009 and ICWFM 2011 was held during 8-10 January 2011. This report aims at providing an overview of ICWFM 2011 regarding its organization, papers, programme, and income and expenditure.

Management of water and flood plays a key role in economic growth and social development. Many of the water and flood management projects have not been able to achieve the desired objectives, because of inefficiency in water use, inequitable distribution of project benefits and costs, inappropriate institutional framework, and inadequate legal and regulatory measures. The emerging issues like global warming and climate change would exacerbate the management problems. Thus, there is a need for concerted effort to identify appropriate water policies, strategies and management practices to achieve sustainable solutions to water and flood management problems. The purpose of the conference was to discuss the above problems and issues and to advance knowledge on water and flood management in order to promote environmentally sustainable development.

Organization of Conference

Announcement

The first announcement of the conference was made in March 2010. The announcement was publicized through postal mails, group-emails, website and circulation of posters and brochures.

Conference Secretariat

A conference secretariat was established at IWFM, BUET since the announcement.

Organizers

The conference was organized by the Institute of Water and Flood Management (IWFM) of Bangladesh University of Engineering and Technology (BUET), in collaboration with Department of Water Resources Engineering, BUET, Water Resources Planning Organization (WARPO), Bangladesh Water Development Board (BWDB), and Local Government Engineering Department (LGED).

Sponsors

Financial supports for the conference were provided by The Embassy of the Kingdom of the Netherlands, Center for Environmental and Geographic Information Services (CEGIS) and Institute of Water Modelling (IWM). An agreement between The Embassy of the Kingdom of the Netherlands and IWFM, BUET, regarding financial support, was signed on December 20, 2010.

Financial contribution was also made by the LGED who collaborated in organizing the event.

A bank account was opened to operate the financial activities of the conference at Sonali Bank, BUET Branch (Current Account No. 33011231).

Registration fee

Registration fee for the participants is shown in Table 1. This fee covered registration materials, inauguration ceremony, and refreshment during conference, pre-conference paper volume and closing dinner.

Financial assistance to participants

A total of 14 participants from developing countries received local financial assistance. The financial assistance covered registration fee, accommodation, food and local transportation during the conference.

Database

A central database was developed to keep record of the received abstracts, papers, and their registration and presentation schedules. It was updated from time to time to organize the whole event smoothly.

Papers and Participants

Selection of abstracts and full papers

According to the first announcement deadline for abstract submission was 15 July 2010, notification of abstract acceptance 31 July 2010, deadline for full-paper submission 30 September 2010, notification of full-paper acceptance 31 October 2010, deadline for registration 15 November 2010.

A total of 176 abstracts were received from 13 countries. These abstracts were reviewed by 21 reviewers. From the submitted abstracts, a total of 145 were accepted and the corresponding authors were notified to submit full papers. Respective authors were notified about the status of their abstracts as per schedule. A country-wise distribution of the received and accepted abstracts is given in Table 2.

Keynote papers

Two renowned researchers from the Netherlands; Professor Elco van Beek and Mr. Kees Slingerland were invited as keynote speaker for ICWFM-2011. Prof. van Beek presented a paper on ‘Water, Climate and Sustainable Development in Delta’s: Integrated approaches and lessons learned’, while Mr. Slingerland did the same on ‘Water and Climate in South Monsoon Asia: Major Challenges for 21st Century’.

Conference proceedings

Format:

A format for the conference proceedings was circulated among the authors. Suggested maximum page limit was eight on a custom-sized paper with 7.5 X 10 inch and 1 inch margin on all four sides.

The pre-conference paper volume has been distributed ahead of the conference among the authors, delegates, guests and committee members. Some additional copies have been kept to distribute to selected libraries inside the country.

Number of participants

A total of 100 authors participated during the conference including 32 participants from abroad. Apart from authors, professionals and delegates from the Netherlands attended the conference. This time a significant number of local delegates attended the conference. A total of fifty members of various sub-committees of the conference also attended the conference. A complete list of participants: authors, keynote speakers and delegates followed by a separate list of authors who received local financial assistance is provided in APPENDIX-II.

Conference Program

Distribution of registration kit

Participants from Bangladesh collected their registration materials on 6-7 January, 2011 at the registration desk of IWFMM, while participants from abroad received it from their respective hotel receptions.

Venue

The conference was held at Dhaka Sheraton Hotel at Minto Road.

Inauguration

The three day event from 8th to 10th of January began with an inaugural ceremony where around 250 persons attended. Apart from the authors and organizers guests from different government and non-government organizations attended the inaugural session. Journalists from some of the national dailies and electronic media also joined the inaugural ceremony. Press clippings from some of the newspapers are provided in APPENDIX-III.

After recitation from the Holy Qur'an, Professor M. Shah Alam Khan, Director of IWFM, BUET made a welcome speech. It was followed by address from Professor Abul Fazal M. Nazrul Islam, Vice-Chancellor, BUET who was the chair of the inaugural session gave his speech.

The other one was to the Rubber-Dam project situated at Sherpur and it was organized by Local Government Engineering Department (LGED). Due space limitations only foreign participants were allowed in visit to the irrigation project. The visit to the Rubber-Dam project was later cancelled as only a few of the participants signed up for the visit.

During the visit the participants were shown the pump house and the irrigation canal system and they were involved in the discussion with the local people about the operation and maintenance of the project. There were discussions about how the user groups were formed and how they provide feedback to the authority.
